How the CFP Damages UK Fishing Destroys Fishing Communities

Because all of the governing and decision making powers reside with the EU bureaucrats, the system is open to lobbyist from large corporations. Self employed fishermen from coastal towns in the UK are being told that certain types of fish cannot be caught and that they can only catch limited amounts. If the quota of one type of fish is taken up by a Spanish trawling fleet (as was the case over the last several years), then the local fishermen have no power or recourse.

It DOES NOT Protect Fish Stocks

Three of the top four major commercial fish stocks are being drastically overfished. Through a practice called quota hopping, major European fishing companies have decimated the reproductive stocks. Within ten years, the best estimates state that 90% of fish stocks will be critically endangered.



For 40 years, the EU has been spreading the lie that the CFP would protect fish stocks. The numbers clearly show that this hasn't worked, yet it is still the most pushed line of argument used by government and media today.
